A.J. Gary called the meeting to order at 10:02 a.m. and presided over the meeting with a quorum declared.

NG911 GIS Data Validation Procurement – C.J. Engel informed the Board that with the guidance of the Office of State Procurement and with the assistance of the Arkansas GIS Office, all proposals for a NG911 GIS Data Validation tool had been evaluated as submitted. Further discussions had moved forward with 1Spatial, Inc. to solidify an agreement. A four-year contract at a cost of \$730,600.00 with the potential to extend to a total of seven years at a projected total cost of \$1,235,200.00 is being recommended to the Board. If approved by the Board and then by legislative review, the original term of the contract would commence on August 22, 2022 and go through August 21, 2026. Rusty McMillon made a motion to approve the contract and move forward with 1Spatial, Inc., Doug Sprouse with a second. Motion carried.

Shelby Johnson thanked the staff of the Office of State Procurement for their assistance throughout the process as well as Jonathan Duran with the Arkansas GIS Office for all of his time and effort on the Request for Proposal process.
